Greatch Technology may trend higher after breaking above the RM1.80 resistance and hitting a 4-month high yesterday. Given that the 20-day and 50-day EMAs are starting to turn upwards, additional upside potential may be seen in the near term. A bullish bias may emerge above the **RM1.80** level, with a stop-loss set at **RM1.68**, below the 20-day EMA. On the upside, near-term resistance is seen at **RM2.10**, followed by **RM2.20**.

Entry : **RM1.80–1.92**
Target : **RM2.10, RM2.20**
Exit : **RM1.68**
