All disputes concerning the construction, validity, enforcement and interpretation of the Conditions stipulated herein shall be governed by, construed, and enforced in accordance with the laws of Malaysia. The parties hereby submit to the exclusive jurisdiction of the Courts of Malaysia for the purpose of any suit, action or other proceedings arising out of Conditions herein.
